

#### **Assessments**

It is incredible to say that we are now working our way towards the end of Term 3. This term has been significantly different to what had been planned and with this has come the following question:

'In what ways should we completely change, and in what ways should we maintain the way we do things?'

This question has driven our decision making throughout the periods of online learning we have experienced over the past two years. One way this is having an impact on all students and staff at the College is in how students are assessed.

Previously, set tests, group assignments, series of small class tasks, practical activities, or digital media presentations (*the list goes on*); teachers would shape the tasks they set, in such a way, that each student is able to display their very best work. Assessment is an example of how we are challenged to provide authentic learning opportunities that display student progress.

At present, we are certainly called to 'do it differently' but throwing out all that we know is unlikely to benefit students or teachers in the educative process. In a sense, we aim to be all things to all people. When we assess students, whether at school or remote, we are called to respond to the above question. We are required to be flexible, to enable students to be their best and display their best, and allow students and teachers to experience a much needed sense of fulfillment in their work.

Our donations to date have exceeded \$27,000.00 and still growing.

We raised funds for:

- 1. The Fr Bob Maguire Foundation.
- 2. The Beatrix School and Kurnanlaya Leprosy Care Centre, in Puri, India.
- 3. The Christian Brothers' in Kolkata, India.

All of these organisations provide practical support such as food and clothing alongside programs that bring dignity, respect and hope to each person, irrespective of what has brought them to their door.

# Learning

#### **VCE Exams**

The resilience and perseverance of all our VCE students is something to be admired and, indeed, proud of. In the most important term of the calendar, this disruption was the last thing we needed. However, the way the students attend team calls, reach out to staff and consistently put in the effort is something to be praised.

The **GAT** Exam has again been rescheduled and is now taking place on **Tuesday 9 October.** It will be held at the Edmund Rice Campus and students are required to be on campus by 9.30am. If students are ill, have any symptoms or have attended a COVID exposure site, they are *not* to attend. Parents or Guardians should notify me immediately.

To ensure **VCE Exams** are not interrupted, the Government has given vaccination priority for Year 11 and 12 students undertaking exams, and their teachers and supervisors. You will have received a letter from the College outlining this procedure. This is one way to ensure that any further interruptions to the VCE year are minimised. We take the health of all students very seriously and will implement strict COVID-Safe plans for the GAT, and for all exams that are held at the College.

In recognition of the continued disruptions caused by COVID-19, the VCAA has continued the **Consideration of Educational Disadvantage** (CED) program, first implemented in 2020.

The CED process allows teachers to make professional judgements based on all available information about your child's performance during the year and the degree to which their performance has been affected by the pandemic.

This week, students were asked to fill in a student statement describing the effects that COVID and the subsequent lockdowns have had on their learning. It is obvious that, for many, the effect has not been positive. This Statement will assist College staff to implement the CED process that will recognise these effects. It is vitally important that students submit their Student Statement, so we have a clearer picture of how the pandemic has affected them. The CED applies to a students' Study Score for each unit. The SEAS application is a little different, it is applied through VTAC, applied to the student's ATAR to assist them to gain a place in a Tertiary course. For information about SEAS, please contact Ms Ellwood.

The Term is nearing its end and Unit 3 & 4 students will have an opportunity to participate in **trial exams**. While we are mindful of the pressures placed on students as a result of the lockdown, we trust that the trial exams will provide the students some much needed practice in time management, exam technique and valuable feedback on what they need to focus on in the upcoming external exams. The trial exams will be conducted online via teams, and a timetable will be distributed soon.

I would like to take this time to reflect and to thank all VCE students for their consistency and hard work this term. I encourage them to take some time out of their study schedules each day to ensure they maintain a balance, enjoy the spring sunshine and get some well-deserved rest.

May God be with you all at this challenging time.

## **Remote Learning Assessment**

"You just can't beat the person who never gives up." Babe Ruth

I read this quote from Babe Ruth a while ago and immediately thought about how COVID is just not giving up. There have been times when it seems as if we are not going to win against this virulent virus. Then it occurred to me that Babe Ruth was not referring to his opponents but to himself. We win when we do not give up. I am inspired every day as our courageous students are just not giving up by continuing to engage with lessons, focusing on learning and participating in College life.

During lockdowns, teachers have found gathering evidence of student learning has become increasingly challenging. They have found that maintaining the integrity of assessments difficult as they are not able to create an environment that is fair and equitable for all students. The classroom environment ensures that all students have the same condition and access to demonstrate their learning. When students are working in isolation, they are tempted to seek undue assistance from the internet and their peers.

Parents can assist us to ensure the integrity of assessments by:

- making sure that they are fully prepared for the task
  - o details of the task
  - o content of the task
  - o equipment for the task
- creating an environment that allows them to focus during the task
- removing all distractions and temptations that may entice them to gain an unfair advantage
- encourage them to contact the teacher should they have any issues or questions
- praising them for being authentic to themselves as learners

This would greatly assist us to give parents and students authentic feedback on the student's learning and how they can further improve their understanding and skills. We would welcome any feedback from parents on how we can better support our students during this time of remote learning.

# **Pathways**

This is a tough time for Year 12 students and parents. No doubt the promise of vaccines and some glimpses of a few more freedoms will be helping, however I want to stress that there are many reasons for students to be optimistic about their future pathways.

Firstly, the Universities and TAFE Institutes WANT students! They are competing for your custom. In 2020, in spite of lockdowns, delayed exams and more, around 95% of students who applied for a course via VTAC, received an offer of a place. On top of that, many students found a place via direct applications.

These institutions are well aware of the stresses and difficulties that students have faced in these two years. They have introduced Early Offer schemes to allow students to be offered a place even before the exams. They base these offers on many other factors than the ATAR – contribution to the community, statements of purpose, experiences, leadership, Year 11 results are just a few. I have encouraged every student I meet with to apply this way. It is at least one certainty in an uncertain world! We have quite a few students who are already breathing a sigh of relief. There are closing dates coming up so don't delay. Note: VU Guaranteed is not on the list as it is only available to VU Partner Schools, such as St Mary's College.

In addition, the ATAR itself has become less important at many universities. They are either not using it at all for selection, or are considering other factors – Selection Tasks such as

forms, interviews, folio presentations, or Subject Adjustments – to help select the best potential students.

Another excellent reason to be positive is the VTAC SEAS process – Special Entry Access Scheme – which provides an opportunity for students to explain matters that have impacted their education this year and previously. You will never know how much SEAS helped your application, but many universities allow up to 10 ATAR points to ensure a fair process. All claims are private and are only used to **assist** students gain entry to courses. Find out more at Information on SEAS.

An addition to SEAS in 2020-2021 has been a set of questions about the effects and difficulties of remote learning. **Every** student should answer these questions. The school is also able to provide a rating to VTAC, so it is important that all students complete the **survey** that I will send this week.

Another process that is vitally important to ensure that everyone is treated equitably this year is the VCAA Consideration of Educational Disadvantage – CED. Ms Pastore has described this process in her section of this newsletter. Just be confident that CED will allow the VCAA to moderate student results for the best possible outcome for each student.

Not to forget the students who are hoping to enter the workforce next year, there are a number of Government initiatives and incentives to encourage employers to take on more young people, particularly in Apprenticeships and Traineeships. In addition, there are many Free TAFE courses available in areas of need, including but not only pre-apprenticeships to help young people gain an edge in the employment market. This should be a real positive for our VCAL students and those in VCE hoping to work in 2022. I do encourage ALL students to make a VTAC application as well, to ensure they have plenty of options open to them, so that in the new year they can make the choice that suits them best.

So, keep up the great effort, Year 12s and families! I know there is a wonderful team of concerned and supportive teachers, counsellors, co-ordinators and school leaders here at St Mary's College who have your back. Just contact any of us for assistance. We truly care about the wellbeing and educational outcomes for all our students and we are working hard behind the scenes to support you all.

## Positive messages from an Olympian

On Thursday 2 September, Olympic Gold Medalist Brianna Throssell met with our Year 12s on Teams. Throughout the session, Brianna espoused positive messages about how to approach the next few months: the importance of compartmentalising areas of life in order to carve out a keen sense of prioritisation, powering through disappointment and framing up challenges as opportunities for growth. In doing this, Brianna drew on her own experiences. For example, in 2016/17, she adopted new training methodology under a new coach. Initially, she was slower in the water. However, in 2019, she had the best year of her career. The ignition point between determination and patience – elusive, almost illusionary – is hard to find but always worth searching for.

Finally, Brianna encouraged the students to sacrifice now for their long term futures. She illustrated that sacrifices lead to unexpected rewards – the sun seems to shine that bit brighter - when a body of work, underpinned by real effort, proceeds them.

Students proffered thoughtful questions throughout the session and Mr Luscombe did a great job as interviewer.

R U OK day is a National Day of Action where Australians of all ages are invited to ask their colleagues, classmates and friends R U OK? This is a conversation that could possibly change a life.

Asking someone: 'Are you okay? And are you really okay? are very important questions to ask, especially at the moment in a time when some of us aren't particularly feeling the best and having to carry an extra load that we haven't had before. - 3. Encourage action
- 4. Check in

you're not sure about how someone is feeling, or you think they are acting a little different than usual make sure you ask, 'Are you really ok?'... Ask them today!

#### **Enrolments for 2022**

Please note that we have commenced our planning for 2022 and confirming places for new students to start in Term 1, 2022. Unless we have already been advised, we are presuming that all current students will be returning to the College in 2022.

If a student is not returning to the College, in line with the enrolment policy, one term's notice in writing is required. If the notice is not received on time, one term's tuition fees in lieu of notice will be charged. This requirement is clearly noted in the General Terms & Conditions of Enrolment which forms part of the Application for Enrolment signed by all parents/guardians when their child(ren) was enrolled.

To assist our planning, please advise the College by Friday 17th September 2021 if a student is not returning to the College in 2022. The notice should be addressed to the College Registrar and can be sent via email to <a href="mailto:registrar@stmaryscollege.vic.edu.au">registrar@stmaryscollege.vic.edu.au</a> It will be helpful to receive this notice as soon as possible as it will allow us to offer any vacant places to students on our waiting lists.

If there are siblings of current students wanting to enrol at the College, it is important that parents submit an Application for Enrolment two years prior to the planned year of entry. Siblings are not guaranteed a place if the Application for Admission is late.

Late applicants will be placed onto the waiting list.

Please do not hesitate to speak with the Registrar, Mrs Leah Mason, if you have any concerns regarding this information or if you need further clarification.

## 2021 Fee Accounts

All 2021 Fee Accounts were due and payable by 31 March 2021, unless an approved Payment Plan was in place by this date.

All families wishing to enter a Payment Plan arrangement should have already completed, signed and lodged a 2021 Fee Payment Agreement Form with the Finance Office. If you have not done so, please lodge the relevant documentation as soon as possible.
