#### Context

St Mary's College Melbourne (St Mary's College) is a co-educational Catholic school in the Edmund Rice tradition, established as Christian Brothers' College St Kilda in 1878. St Mary's College is committed to providing a caring, supportive and safe environment where every student has a place, a voice and their story is known. As a Catholic school in the Edmund Rice tradition, our Christian values are those expressed in the Touchstones of our governing body, Edmund Rice Education Australia (EREA): Liberating Education, Gospel Spirituality, Inclusive Community, Justice and Solidarity. The charism of Blessed Edmund Rice expressed through these touchstones, underpins our continued commitment to a safe and inclusive environment for all, providing a preferential option to those at the margins, to grow in empathy and to respond in faith and action.

This policy should be read in the context of the College Child Safeguarding (Safety and Wellbeing) Policy and Procedures, and Student Duty of Care Policy.

## **Background**

EREA, as St Mary's College's governing authority, sets the policy framework for all EREA schools. These policies have been contextualised for St Mary's College's particular school environment so that our policies reflect the needs of our students.

## Rationale

St Mary's College is committed to being a place of welcome and safety for students and their families. The welfare of each St Mary's College student is our foremost priority and we are committed to strengthening the wellbeing and learning outcomes of all students within a safe, inclusive and respectful learning environment.

#### **Principles**

The Education Training and Reform Regulations 2017 (sch 4 cl 12) require that the College must ensure that the care, safety and welfare of all students attending the College is in accordance with any applicable State and Commonwealth laws, and that all staff are advised of their obligations under those laws.

## Senior Secondary Colleges

The Education Training and Reform Regulations 2017 (sch 8 cl 3) require that:

 a senior secondary education provider must have policies and procedures in place that are consistent with any relevant legislation to ensure the care, safety

- and welfare of students and the provision of opportunities for students with special needs to access courses; and
- if two or more senior secondary education providers share the responsibility for providing an accredited senior secondary course or its components to a student, each of those providers must have procedures in place to identify and satisfy the legal duties owed to the student while the student attends, travels between or undertakes an excursion with the providers.

# **Policy Statement**

St Mary's College has a range of student welfare and safety policies designed to ensure the care, safety and welfare of all students at the College. All staff are advised of their obligations under relevant laws, including child protection and occupational health and safety laws, at induction and then on an ongoing basis at least annually and when necessary.

In addition to a high-level Student Duty of Care Policy which explains the duty of care owed to our students and how staff are required to discharge their duty of care, the College has developed a complete Student Duty of Care Program which addresses specific student care, safety and welfare issues at the College.

## **Procedures**

St Mary's College's Student Welfare policies and procedures take into account that different and sometimes greater measures may need to be taken for vulnerable students, younger students or students with disabilities, in order for the College to provide the best care for our students and to discharge our duty of care.

In accordance with the Victorian Child Safe Standards and Ministerial Order No. 1359, the College has developed and implemented a complete Child Protection Program. This Program enables the College to effectively manage the risk of child abuse in all College environments, promptly and appropriately respond to all allegations of child abuse, meet our duty under the Wrongs Act 1958 to take reasonable precautions to prevent the abuse of a child and maintain a zero tolerance approach to child abuse. ## Students with Special Needs

Students with special needs are afforded the same access to courses in accordance with our Disability Discrimination Policy.

St Mary's College is committed to making reasonable adjustments for students with special needs. Individualised programs will also be developed for students with disabilities in consultation with parents/carers and relevant experts, to ensure access to courses.

# <u>Shared Responsibility for Courses with Other Providers</u>

Where the College shares responsibility for a senior secondary course with another provider, we maintain a copy of the written agreement between the providers that states how each party manages its legal and child safety obligations for these students. This includes how each student attends the course, travels between the providers, or goes on excursions.

### Documentation

The College maintains documentation in relation to our responsibilities to students with special needs who access senior secondary courses.

This documentation is maintained by the Learning Diversity Leader and copies of all documents are stored on the staff collaboration drive.

# STUDENT DUTY OF CARE HOME PAGE

The college and its teachers owe a common law duty of care to take reasonable steps to protect students from any injury that may be reasonably foreseen. This requires teachers and principals not just to react to situations as they arise but to engage in appropriate risk management to reduce the risk of injury.
